**BY-LAW NO. 4946**

**BD 24**

A BY-LAW of the Municipal Corporation of the City of Yellowknife in the Northwest Territories, to amend the Dog By-law No. 4755.

PURSUANT TO Sections 70(1)(i) and 72 of the *Cities, Towns and Villages Act*, S.N.W.T., 2003, c. 22, and the provisions of the *Dog Act*, R.S.N.W.T., 1988, c. D-7.

WHEREAS the Municipal Corporation of the City of Yellowknife deems it desirable to provide for the regulation, control, licensing and prevention of cruelty to dogs.

WHEREAS the Municipal Corporation of the City of Yellowknife wishes to amend the Dog By-law No. 4755.

NOW, THEREFORE, THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

**APPLICATION**

1. That Dog By-law No. 4755 is hereby amended by:

A) Adding a new Section 27 (5) to read as follows:

27(5) No person shall exercise, walk, or run, a dog while operating a motorized vehicle, including but not limited to a motor vehicle as defined in the *Motor Vehicles Act* of the Northwest Territories,

B) In Section 29(1) after the word "Section" replace the number 27 with 28.

C) In Section 35 after the word "Section" replace the number 33 with 34.

D) In Section 43 after the word "Section" replace the number 41 with 42.

E) In Section 45 (b) after the word "Section" replace the number 47 with 62 and after the second word "Section" replace the number 50 with 51.

F) In Section 47 after the word "Section" replace the number 59 with 60.

G) In Section 49 after the word "Section" replace the number 53 with 51.

H) In Section 50 after the word "Section" replace the number 50 with 51.

I) In Section 51(b)(ii) after the word "Subsection" replace 50(b)(i) with 51(b)(i).

J) In Section 52 after the word "Section" replace the number 44 with 45.

K) In Section 63 after the word "Section" replace the number 59 with 60.

EFFECT

2. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the *Cities, Towns and Villages Act*.
