CITY OF YELLOWKNIFE BY-LAW NO. 4362

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife in the Northwest Territories, authorizing the Municipal Corporation of the City of Yellowknife to amend the City of Yellowknife Niven Lake Development Scheme 2004 By-law No. 4339.

PURSUANT TO:

- a) Section 25 to 29 inclusive of the *Planning Act*, R.S.N.W.T., 1988, c. P-7;
- b) Due notice to the public, provision for inspection of this by-law and due opportunity for objections thereto to be heard, considered and determined; and
- c) The approval of the Minister of Municipal and Community Affairs, certified hereunder.

WHEREAS the Municipal Corporation of the City of Yellowknife has enacted Niven Lake Development Scheme 2004 By-law No. 4339;

AND WHEREAS the Municipal Corporation of the City of Yellowknife wishes to amend Niven Lake Development Scheme 2004 By-law No. 4339;

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

APPLICATION

- 1. That Niven Lake Development Scheme 2004 Schedule No. 1 to Bylaw No. 4339 is hereby amended by:
 - A) Deleting Section 1a) and adding a new Section 1a) as follows:

"The Niven Lake residential area shall provide for detached, manufactured (double wide), duplex, multi-attached and multi-family dwellings, as defined under Zoning By-law No. 4024, in areas designated LD - Low Density and MD - Medium Density."
