## **FIRE BAN LIFTED**

Effective immediately, the mandatory ban on open-air fires that was put in place on Thursday, June 20, 2024, at 12:00 p.m. (noon) has been lifted for the City of Yellowknife due to recent precipitation and cooler temperatures. A fire ban may be issued if fire danger conditions are extreme and necessitate a ban.

Please practice fire safety at all times, burn responsibly, and ensure your fire is cold before leaving. All fires must be in an approved fire pit and require a burn permit. For more information on City of Yellowknife burn permits and to request a permit visit: <u>www.yellowknife.ca</u>.

#### Before having a fire, remember:

- The fire must always be supervised and completely extinguished (soaked with water, stirred, and soaked again until cold) before leaving;
- Do not have a fire if there are substantial winds; and
- Burning yard waste requires a separate permit.

### FROM THE SOLID WASTE FACILITY...

#### Grass Clippings and Leaves

Leaves, grass clippings, and small brush can be brought to the Solid Waste Facility (SWF) and disposed of free of charge when placed in a paper bag. However, when this waste comes to the SWF in plastic and other non-compostable bags, it is considered residential garbage and is subject to the associated charges. Let's work together to divert as much waste as possible from the landfill by ensuring that no plastic is mixed with leaf and yard waste.

#### Animal Waste

The City of Yellowknife reminds residents not to place animal waste in their green cart. Animal waste should be taken to the Solid Waste Facility, free of charge, and placed in the yellow Animal Waste bin for safe disposal. The SWF is open to the public from **11:00 a.m. to 4:15 p.m., Tuesday to Sunday**, closed to the public on **Mondays**.

#### **Cycling Etiquette**

- Be Courteous signal to pedestrians and other cyclists by voice, bell or hand signals.
- Obey all signs and rules of the road.
- Be visible wear bright clothing and reflective gear to help vehicles see you.
- Stay on the right-hand side of the road and ride in the same direction as traffic.

# FREE HOME AND PROPERTY ASSESSMENTS

The City of Yellowknife Fire Division (YKFD) is conducting free home and property assessments for Yellowknife residents. This assessment will highlight areas of risk and provide specific recommendations of actions and upgrades residents can take to increase their property's resilience to wildfire.

The program's primary purpose is to engage homeowners in voluntary wildfire mitigation activities by offering a home assessment with property-specific recommendations. The assessment process accurately evaluates a home and property for wildfire exposure, while engaging the homeowner to discuss their unique fire risk and guidance as to how to reduce it. This program is being offered in collaboration with FireSmart Canada, FireSmart NWT and homeowners in Yellowknife.
