SNOW REMOVAL SCHEDULE

No snow removal in observance of Remembrance Day.

• Forrest Drive from Franklin Avenue to Con Road.

Friday, November 15, 2024

- 46, 45 and 44 Streets from 49 Avenue to Franklin Avenue; and
- 54 Street from Franklin Avenue to end.

Residents must ensure parked vehicles are removed from these streets by midnight, or they will be towed. Residents are advised that there will be traffic delays in snow removal areas and if possible, to use an alternate route to avoid delays. The City asks residents to ensure Curbside Carts are returned to their property before the scheduled snow removal on their street. Thank you for your patience, and remember to use caution in snow removal areas and not to pass moving equipment.

WINTER STREET MAINTENANCE

The City conducts snow removal, plowing, and winter sanding to improve traction, enhancing safety for pedestrians and drivers. Snow removal follows a priority system, where high-traffic areas and those near schools receive precedence over lower-traffic residential streets.

We appreciate your continued patience as we work to clear snow from City streets. Some residents have requested snow removal on their streets, but we may be unable to accommodate these requests immediately. Expediting any request would mean delaying removal on streets with higher priority, which may be assigned due to factors like high vehicle or pedestrian traffic, proximity to schools, narrow street width (a public safety concern), trucked services, or bus routes. However, we do assess resident concerns, and if a street is not scheduled for removal soon, the City may deploy a grader to improve road conditions. In the meantime, please continue to drive safely.

SNOW REMOVAL DURING HEAVY SNOWFALL

In cases of heavy snowfall, the City may need to push snow toward curbs to keep roads passable. This can create a snow ridge across driveways and may result in snow on sidewalks, requiring residents to clear their driveway entrances and, if possible, assist with sidewalk clearing. According to Highway Traffic By-law No. 5055, residents must avoid pushing snow from their driveways back onto the street, as this can create a traffic hazard.

SEEKING INPUT ON LIVERY LICENCE BY-LAW

The City of Yellowknife (the City) is seeking public feedback as it prepares to modernize Livery Licence By-law No. 4526 - a By-law which regulates taxi licensing and related matters.

From November 1 - 30, 2024, taxi companies, drivers and members of the public who rely on taxis are invited to share their general feedback on the current Livery Licence By-law as well as on the proposed changes via a survey on PlaceSpeak. This survey will be advertised on the City's social media channels throughout the month of November. Note that in order to complete the survey, residents must reside within the city limits and sign up for an account.

The proposed changes to the by-law address the increased cost of operating taxis, safety considerations and other matters that have been raised by taxi operators and taxi users.
