- c. amending Map 2 to reflect the change in land use designation;
- d. amending Map 9 to reflect the change in land use designation;
- e. amending Map 11 to reflect the change in land use designation;
- f. amending policy section 4.8 Kam Lake to reflect the decrease in land area designated;
- g. amending policy section 4.17 Special Management Zone by removing and replacing the policy of this section, and deleting Map 20 in its entirety; and
- h. amending policy section 7 by deleting the definition of 'Work Camp'.

#### Sidewalks

The City would like to remind businesses and residences in the Central Business District, Franklin Avenue from Matonabee Street to Old Airport Road, and Franklin Avenue from 44th Street to School Draw Avenue to keep the sidewalk(s) around their properties clear of ice and snow, and otherwise safe for pedestrian traffic. Failure to do so may result in a fine or other enforcement action pursuant to Highway Traffic By-law No. 5055. Let's work together to keep our sidewalks safe!

# TOURIST ACCOMMODATION TAX COMES INTO EFFECT ON APRIL 1, 2025

The Tourist Accommodation Tax By-Law No. 5099, passed by the Yellowknife City Council in 2024, comes into effect on **April 1, 2025**. This By-Law requires that a 4% tax be applied to the purchase price of tourist accommodation in the City. The funds collected will be used to enhance and grow the tourism sector in Yellowknife.

All operators of licensed tourist accommodation within Yellowknife must comply with this new tax. This includes both larger commercial properties and short-term rental hosts. Accommodation operators must report and remit the tax quarterly, with the first deadline on July 30, 2025. Payments can be made online through a new portal on the City of Yellowknife website that will launch prior to the first remittance date.

Certain situations exempt guests from the tax, including long stays (over 30 days) and specific government-related stays. For further details, visit the City of Yellowknife's <u>website</u>.

#### **Space Heater Fire Safety**

- Turn the heater off when leaving the room or going to bed; and
- Ensure it has a ULC or CSA label which shows it is tested to Canadian standards.

#### SNOWMOBILE SAFETY

With many Yellowknifers out on snowmobiles this season the City reminds everyone to keep these safety tips in mind:

- There are speed limits for snowmobiles learn and follow them;
- Always drive at a speed that will let you stop safely;
- Be mindful of, and slow down for, other trail users such as hikers, skiers, skaters and dogsleds;
- Valid snowmobile registration and insurance is required when operating in City Limits;
- Helmets are mandatory for all snowmobile riders and operators;
- Remember to dress appropriately and let someone know where you're going and when you expect to return.

To help ensure everyone is snowmobiling safely the City's Municipal Enforcement Division regularly patrols lakes and trails.
