REACHING HOME FUNDING AVAILABLE

Near the end of 2023, the City of Yellowknife secured a four-year extension on their federal Reaching Home funding agreement. From April 1, 2024 to March 31, 2028, the City will continue to receive funds annually to address homelessness and housing needs in Yellowknife.

As we head into our second year of the four-year extension, the City is seeking project proposals from NGOs and charitable organizations geared towards supporting our local unhoused community. For the upcoming fiscal year from April 1, 2025 to March 31, 2026, \$535,000 of Reaching Home funding will be available to support these projects.

To apply for this funding, NGOs and charitable organizations are invited to send their project proposals to the City's Homelessness Division at homelessness@yellowknife.ca by January 31, 2025 at 12:00 p.m. (noon). Submissions must focus on impactful, start ready initiatives, and align with the Government of Canada's Reaching Home directives.

Proposals will be reviewed, and funding decisions made by the Community Advisory Board on Homelessness in March 2025. Once the funding allocations have been determined, successful applicants will be contacted directly. CITY BEGINS EXTINGUISHING EFFORTS

The City of Yellowknife would like to advise the public that extinguishing efforts have commenced at the Solid Waste Facility. This operation marks a significant step towards the full extinguishment of the ongoing subsurface fire at the facility. The City is prioritizing resource needs to ensure the safety and effectiveness of the firefighting efforts. This initiative is guided by the Yellowknife Landfill Control and Risk Reduction Plan (2007) and the guidelines set by the Solid Waste Association of North America. While firefighting activities are being performed, the affected area of the Solid Waste Facility will be closed to the public. For the time being, the rest of the Solid Waste Facility will remain open during regular operating hours from Tuesday to Friday. The facility remains closed on weekends until the incident is resolved. A temporary closure of the entire facility may be considered at a later date if warranted.

Clear signage and barriers will mark the restricted area to prevent unauthorized access. Please be aware that there may be increased smoke and a smell emerging from the site of the incident as work is being conducted. The City continues to closely monitor air quality alongside regulatory partners. For further updates, please visit our <u>website</u>.

Residents must ensure parked vehicles are removed from these streets by midnight, or they will be towed. Residents are advised that there will be traffic delays in snow removal areas and if possible, to use an alternate route to avoid delays. The City asks residents to ensure Curbside Carts are returned to their property before the scheduled snow removal on their street.

Trucked Service Access

The City would like to remind properties on trucked water and sewer to keep access to their service connection points clear of snow and ice. If the connection points are not accessible water delivery and/or sewage pumpout may not occur until access problems have been fixed.

2024 ASSESSMENTS FOR 2025 TAXATION

Property Assessment Notices have been mailed to all ratepayers (persons or businesses responsible for paying property taxes). An assessment is a value placed on property (land and buildings) for municipal and school tax purposes. For information regarding school support declarations and assessment appeals, please consult <u>A Guide to Property Taxes</u>. Appeals may only be filed against the assessment values of your property, not the amount of taxes collected. Note that the deadline to file a school support declarations, or to make an appeal, is **February 20, 2025**.

Property owners can compare assessment with other similar properties in their neighbourhood using the City's online tool, CityExplorer. For land comparisons, ensure similarity of location, lot size and zoning. For building comparisons, ensure similarity of age, quality, style and size.
